CHAPTER - 3

TERMINOLOGY OF RULING A CITIZEN

There are few fundamental rights which are bestowed on a citizen under any government. The government should pay respect to these rights such that citizens can lead their life smoothly and human values are inculcated in the society. The purpose of fundamental rights is to honor the citizens in such an aptitude that an ideal societal behavior is developed among the citizens. The fundamental rights guarantee ideal form of governance such that human rights are developed at all over places. The fundamental rights provide relief to the citizens from torturous modes in livings which are prevalent in the society.

Fundamental rights guarantees free exercise of aptitudes in work culture such that citizens are not bothered of torturous modes in livings and law guarantees security in the work culture by bestowing fundamental rights on the citizens. Fundamental rights are such that all modes in political chicanery are taken into considerations and law guarantees complete statehood to the citizen. Fundamental rights are required in the functioning of the government such that ideal statehood is bestowed on the citizen. Fundamental rights should be variously developed under circumstances which may be oversubscribed for the citizen.

The whole purpose of fundamental rights for a citizen is to uphold the dignity of the individual and develop a societal behavior such that human values are inculcated in societal behavior. Fundamental rights are required in the functioning of the government such that citizen is least bothered of his aptitude in work culture. Fundamental rights guarantee peace of mind to the citizens such that developmental folds can easily be carried out in open arenas. The purpose of Fundamental rights can be carried over to the extent of extremely isolated societies such that least misdemeanor inculcates in the functioning of the government. The association of law has to guarantee such functioning in governance that humanistic approach is applied to the society.

The natural instinct of mankind is they want returns for the work they have done. The natural instinct of mankind is they want freedom of various kinds in their lifestyle. The fundamental rights are thus developed to honor the citizen of the benefits that are to be accrued to the citizen. Different countries bestow various fundamental rights on the citizen according to the norms of their country. The purpose of Fundamental rights is to provide justice to the citizen only on grounds which are

justifiable to his character and not on false grounds. The purpose of Fundamental rights is to honor the citizen within the boundaries of the work culture in the country.

The purpose of law is to guarantee fundamental rights to the citizen within the boundaries of the work culture in the country. Fundamental rights are abolished under conditions of emergency in the country. The fundamental rights are guaranteed only on basics of developing work culture in the society and they are not necessarily to be questioned in the court on grounds which may be abnormal to his life cycle. The fundamental rights should be bestowed on the citizen only when he has proved his worth to the society. The fundamental rights guarantee complete statehood but they should not be interpreted in a fashion to accrue personal gains. Thus citizens should develop an aptitude in work culture so that fundamental rights can be guaranteed to the citizen. The citizens should associate such norms that his personal rights are as much respectable as other citizen's rights. When such type of work culture is developed than only fundamental rights can be guaranteed to the citizen otherwise whole concept of fundamental rights abolishes in itself.

Fundamental rights can be enforced in the court only on grounds of violation of personal liberty of the citizen or when individual privacy is under threat. Fundamental rights are tough procedures to practice in court until and unless there is certified evidence to prove that personal liberty or individual privacy is threatened. Court as such is helpless to guarantee fundamental rights until there is open evidence to prove that such sequence of events has taken place that personal liberty is threatened. Fundamental rights should enforce new lease of life for the citizen who is a victim of circumstances.

Fundamental rights are now put on threshold of duties associated with the works of benefits gained by the citizen. Thus to entail fundamental rights it is essential that you perform certain fundamental duties to the government, it is essential that you prove yourself worthy to the country and your worth is respected only then you are eligible to entail fundamental rights under the state. Fundamental duties are chartered in such a fashion that they demand from the citizen that he is not a culprit to the nation but a worthy citizen of the country. Fundamental rights are thus now put on the threshold of fundamental duties to the nation. For an individual to enforce fundamental rights in a court of law has now become a cumbersome process. He has to lend a safe pair of hands to the nation by following certain obligations to entail fundamental rights.
